Hotel Demand, Rate, Occupancy, Revenue, and REVPAR Data: May 2009

- During the month of May 2009, Massachusetts state wide lodging room demand (1,492k) decreased 7.8% compared to May 2008 (1,618k). The average daily room rate between these two periods decreased by 6.3% to \$137.16 from \$146.40. Occupancy rates, which reflect changes in both supply and demand for rooms, decreased by 5.9 percentage points to 59.9% from 65.8%. Overall room revenue decreased 13.6% to \$204.6 mil from \$236.8 mil.
- REVPAR, which is a function of occupancy rate and room rate, decreased for CYTD 2009 over same period in CY2008 by 18.6% to \$61.25 from \$75.26. Occupancy was down 11.0% and the room rate decreased by 8.6%.

Room Occupancy Taxes: May 2009 (Fiscal Year 2009)

- For the month of May 2009 (FY09), the net room occupancy tax collections of \$11.2 million decreased by 21.6% from the May 2008 (FY08) collections of \$14.2 million. The May 2008 collections were a 13.0% increase over the May 2007 (FY07) collections of \$12.6 million.
- For the Fiscal Year 2009 thru May 2009, net room occupancy tax collections totalled \$147.0 million, a 7.2% decrease from the same period of FY08. The FY08 collections of \$158.4 million were 11.4% more than the FY07 collections of \$142.2 million.

Ma Tourism Fund (MTF) Collections: FYTD May 2009 (FY09)

The FY2009 to date thru May 2009 Massachusetts Tourism Fund collections were down 19.4% compared to the collections for the same period in FY2008 (\$30.7 million v. \$38.1 million). The FYTD May 2008 collections were 7.9% higher than the FYTD May 2007 collections (\$38.1 million v. \$35.3 million).

Museum and Attraction Attendance: May 2009 and CYTD 2009

Massachusetts' museum and attraction attendance decreased 0.6% in the month of May 2009 compared to May 2008 (1,108,319 visitors v. 1,189,766 visitors). The total net visitor decrease was 81,447 at the 59 institutions reporting visitor data.

For all of calendar year 2009 thru May attendance was up 1.3% to 4.2 million from the 4.1 million attendees during the same period in 2008.

Logan International Airport Passenger Volume: May 2009

- In **May 2009**, the number of **domestic passenger** arrivals and departures from Logan International Airport totaled 1.9 million, a decrease of 4.7% from the May 2008 total of 2.0 million. Calendar year to date thru May the total was 8.4 million down 8.3%.
- The number of **international passenger** arrivals and departures decreased in May 2009 by 11.1% compared to May 2008 to 312,065 from 351,065. Calendar year to date totals thru May are down 12.2% to 1,398,113 from 1,591,761.

There was a 3.8% increase in domestic visitation to MA in FY2008 compared to FY2007. The primary trip purpose in FY2008 was visiting friends and/or relatives, the top activity was attending a family/social event, and 66% of visitors arrived in their own vehicle. Of the visitors that stayed overnight, 47% stayed in a hotel/motel/inn or B&B.

Travel to Massachusetts from MOTT target markets in CY02008

Estimated OVERSEAS visits to Massachusetts during **CY2008** was just under **1.3 million**. This was a 8.2% increase over the **CY2007** estimate of **1.2 million**.

Historically, the top five origin countries to visit MA have been Canada, the United Kingdom, Germany, France and Italy.

For CY 2009 through April 2009, visitation from Canada to U.S. dropped 8.9%, while WE visits declined 12.5% compared to 2008.

Direct Economic Impact of Travel and Tourism, CY2007

Domestic and International travelers directly spent over \$15.1 billion in MA during 2007, up 6.6% from 2006. Domestic traveler spending increased 6% while international traveler spending increased 11.1%. Total expenditures generated \$943.5 million in state and local taxes for MA.

MASSVACATION.COM Activity: June 2009 & CYTD Thru June 2009

The **MASSVACATION.COM** site had **111,985 unique visits** in **June 2009**, down 21.2% from 142,164 in June 2008. Additionally, there were **649,555** page views in June, down 16.8% from the **780,593** in 2008. The average time on the site was up almost 22.1% to **4 minutes 33 seconds**.

For CY2009 through June 2009, the total **visits** were **520,430** and the **page views** were **3,039,678**. The average time on the **site was 4 minutes 14 second**. The United States generated the most website visits with **451,947**. Canada followed with **21,576** and the United Kingdom was third with **9,146**.

The **Mass Value Pass** page had the most visits for CY2009 through June 2009 with 326,107. The top three region pages were Cape Cod (69,259 views), Greater Boston (70,226), and Western Mass (77,248).

GETAWAY GUIDE Distribution: June 2009

The total number of **2009 Getaway Guides** distributed in **June** was **52,115**. Of these, **10,699** were **individual requests from FARM** (the online fulfillment system). Most of the remaining guides were sent to major information centers across the state (30,150), hotels and motels (1,600), and 1,350 were sent to AAA info centers.

Lesbian Gay Bisexual Transgender (LGBT): June 2009

The Community Marketing, Inc. 13th Annual LGBT Tourism Study found that **Boston** ranked **9th** with **17.1%** visitation among cities visited in the last 12 month for **Leisure (11.5%)** and **Business (5.6%)** by the LGBT community.

The **LGBT micro site** was launched on January 23 and the site utilization has been fantastic. Since inception thru June 2009 there have been 39,535 visits and 102,987 page views.

The top five information pages viewed were capemass, marriage, bostonmass, westmass, and southmass.
